# **Tree Line Updates**

Tree Line continues to expand both its AUM and portfolio with the addition of new funds and financings. We remain healthy, liquid and expect to be very active in the final months of 2020. We are also excited to welcome two new members to our team as we expand our footprint across the U.S.

## Key Firm Updates

- Since May 2020, completed five add-on acquisition financings for existing borrowers and two financings for new sponsor relationships
- Completed the first annual Tree Line Ascend Report to examine lower middle market private equity deployment expectations and criteria for the year ahead
- Opened an Austin office and added two members to the Tree Line team, Tina Badciong and Grant Heatley

Tree Line has provided the lower middle-market with over \$1.6B in commitments and over 90% of our activity started with companies less than \$15M of EBITDA. Frank Cupido, Partner of Tree Line, adds, "As a leading lower middle-market direct lender, we provide sponsors the important combination of a financing solution to meet closing requirements but with meaningful capabilities to expand through add-on acquisitions. For sponsors considering a buy & build strategy, we have a strong track record and reputation for delivering long-term value as an investing partner. We are encouraged by the activity we're seeing build on our pipeline and remain focused on supporting both existing and new sponsor relationships in this environment."

- Our Ascend Report (available <u>here</u>) provides valuable insights from over 50 participating sponsors; we are well-aligned with these groups as the collective data set suggests high confidence in robust future deployment
